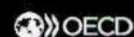

## What is due diligence?

Conducting due diligence helps businesses, at all stages of agricultural supply chains, identify and address key risks related to the environment, human rights, labour rights, and corruption across their own operations, as well as among their suppliers. How a company applies due diligence depends on the sector, commodity, supply chain, and market realities.

Most environmental and social challenges in agricultural supply chains take place at the farming and processing stage, including across the approximately 20 countries of the broader MENA and Türkiye region. For example, droughts alone lead to significant declines in agricultural production and livestock over the past three decades, totalling USD 3.8 trillion in losses<sup>1</sup>. Climate-smart measures are needed to mitigate and adapt to climate change, as the volume of available water is projected to decline by up to 45%<sup>2</sup>. Similarly, cotton farming in the region is predominantly undertaken by smallholder farmers, whose production models often involve family members, such as women and children, raising concerns around child labour<sup>3</sup>. Agriculture is one of the lowest-paid, most informal sectors, with up to 94% of agricultural workers in informal jobs in certain countries<sup>4</sup>.

OECD standards on due diligence provide business with internationally recognised, government-backed guidance that can help them improve the impact of their business operations and supply chains. They do not expect companies to be perfect in everything, everywhere, all at once. Instead, they encourage companies to prioritise their most significant impacts and engage with business partners and stakeholders to create meaningful improvement over time.
